NOTICE OF PUBLIC MEETING AND NOTICE OF COMPLETE APPLICATION CONCERNING A PROPOSED ZONING BY-LAW AMENDMENT

TAKE NOTICE that the Council of the Corporation of the Township of Otonabee-South Monaghan has received a complete application for an amendment to the Township of Otonabee-South Monaghan Comprehensive Zoning By-law No. 2010-65, and is notifying the public in accordance with Section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

AND TAKE NOTICE that the Council of the Corporation of the Township of Otonabee-South Monaghan will hold a public meeting on **Monday March 18th, 2019 at 6:00 p.m. at the Township Office, 20 Third Street in Keene**, to consider a proposed Zoning By-law Amendment under Section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

Location of the Subject Lands

The proposed Zoning By-law Amendment applies to a property that is located in Part of Lot 18, Concession 7, in the Otonabee Ward of the Township of Otonabee-South Monaghan. The rezoning applies to the severed and retained lands of a current consent application (B57-18) as well as the severed lands of a previous application (B172-06) which are adjacent to each other. The severed lands of B57-18 are being added to the previously severed lot (B172-06) to become one property. The civic address for the subject lands is 1578 Heritage Line. There is a key map attached for reference.

Purpose and Effect of the Proposed Zoning By-law Amendment

The proposed Zoning By-law Amendment is required as a condition of approval for consent application B57-18. The subject lands are currently zoned Rural (RU) and Environmental Protection (EP) in By-law No. 2010-65 of the Township of Otonabee-South Monaghan. The purpose and effect of the Zoning By-law Amendment is to:

- (1) Rezone the severed parcels of Consent applications B172-06 and B57-18 from the Rural (RU) zone to the Rural Residential (RR) zone; and
- (2) Rezone portions of the retained parcel from the Rural (RU) zone to the Environmental Protection (EP) zone to conform to the Township Official Plan.

Representation

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Township of Otonabee-South Monaghan to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan

before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Otonabee-South Monaghan before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

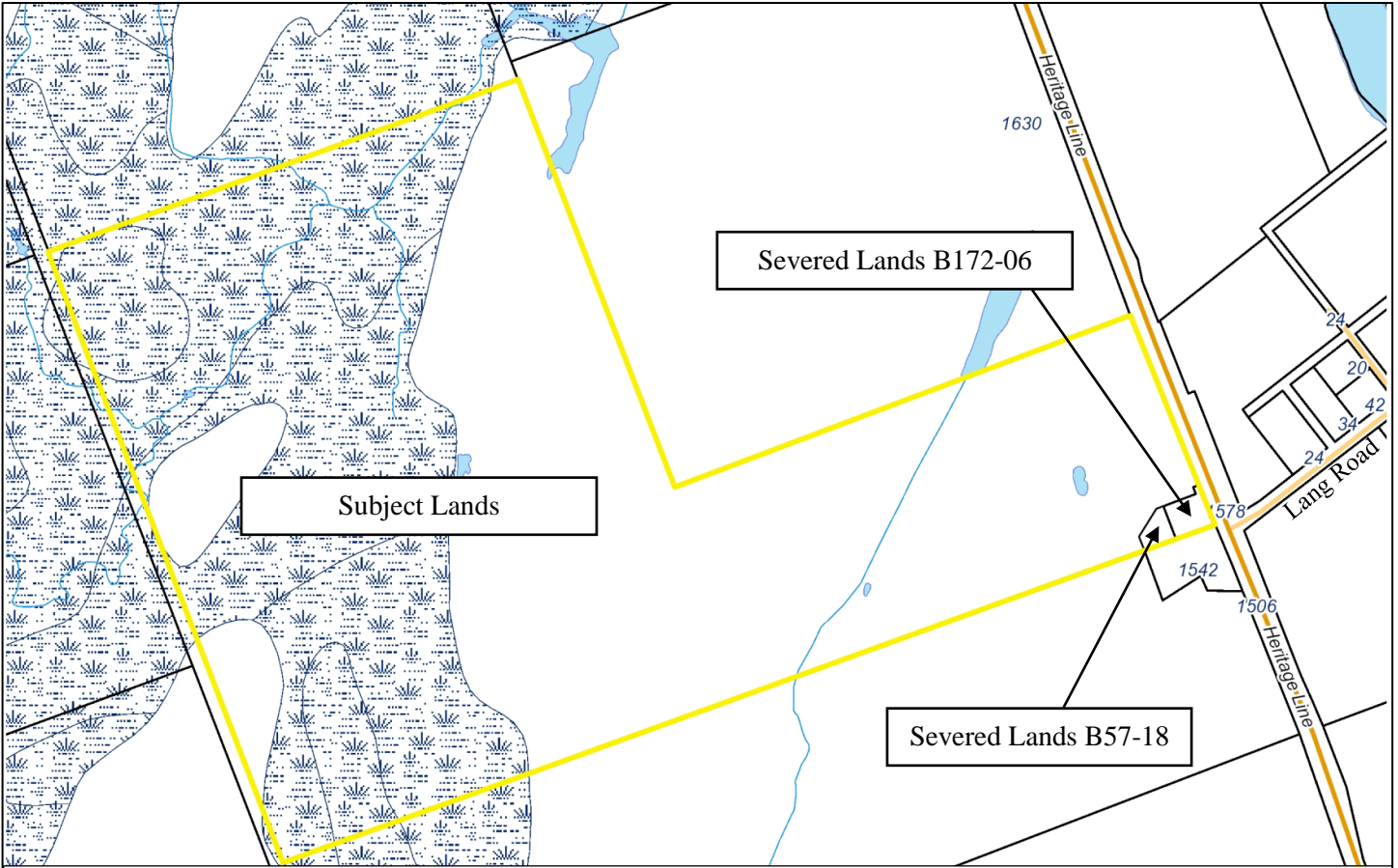
