NOTICE OF COMPLETE APPLICATION AND PUBLIC MEETING CONCERNING AN APPLICATION FOR A ZONING BY-LAW AMENDMENT

TAKE NOTICE that the Council of the Corporation of the Township of Otonabee-South Monaghan has received a complete application for an amendment to the Township of Otonabee-South Monaghan Comprehensive Zoning By-law No. 2010-65 and is notifying the public in accordance with Section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

AND TAKE NOTICE that the Council of The Corporation of the Township of Otonabee-South Monaghan will hold a public meeting on **Monday, May 25th, 2026, at 6:00 p.m.**, in the **Council Chambers, Township of Otonabee-South Monaghan Municipal Building, 20 Third Street, Keene, Ontario**, to consider a proposed Zoning Bylaw Amendment, pursuant to Section 34 of the Planning Act, R.S.O. 1990, c.P.13.

Location of the Subject Lands

The proposed Zoning By-law Amendment applies to a property that is located at Concession 1, Part of Lot 2 in the Otonabee Ward of the Township of Otonabee-South Monaghan. The subject lands are known as 100 County Road 2. (Key Map below).

Purpose and Effect of the Proposed Zoning By-law Amendment

The proposed Zoning By-law Amendment is required as a condition of Consent approval for Application B-101 and 102-25 which proposes two (2) residential severance.

The subject lands are currently zoned Rural in By-law No.2010-65 of the Township of Otonabee-South Monaghan. The purpose and effect of the Zoning By-law Amendment is as follows:

- (1) That the Severed lands(B-101-25) be rezoned from the Future Development (FD) Zone to the Hamlet Residential (HR) Zone to acknowledge the residential uses; and
- (2) That the Severed lands(B-102-25) be rezoned from the Future Development (FD) Zone to the Hamlet Residential-XX (HR-XX) Zone to acknowledge the residential uses and the deficient lot frontage; and
- (3) That the retained lands be rezoned from the Agricultural (A) Zone to a Site- Specific Agricultural-XX (A-XX) Zone to acknowledge the deficient lot frontage.

Representation

If a person or public body would otherwise have an ability to appeal the decision of the Council to the Township of Otonabee-South Monaghan to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

Notwithstanding the above, subsection 34 (19) of the Planning Act defines the parties that are eligible to appeal the decision to the Ontario Land Tribunal.
