Application for a Minor Variance filed under the provisions of Section 45 of the *Planning Act*, R.S.O. 1990, as amended, to be heard by the Committee of Adjustment of the Township of Otonabee-South Monaghan.

APPLICANT: Daryn Bozek

PROPERTY: 41 Golden Meadows
Concession 16, Part of Lot 21,
Otonabee Ward, Township of Otonabee South-Monaghan
(Key Map below)

PURPOSE AND EFFECT OF APPLICATION:

Relief through a Minor Variance is requested from the following provisions of By-law No. 2010-65 of the Township of Otonabee South Monaghan:

- (1) Decreased the rear yard pool setback from the required 1.2 metres to 0.75 metres; and
- (2) Decreased the interior side yard setback from 3.0 metres to 2.1 metres in order to accommodate the pool equipment.

The purpose of this Minor Variance application is to permit the construction of a new pool and pool equipment that encroach into the side and rear yard setbacks.

The subject lands are currently zoned Rural Residential-18 (RR-18) which permits a residential dwelling and accessory uses such as a swimming pool. The applicant is requesting to reduce the rear yard setback from the required 1.2 metres to 0.75 metres for the swimming pool and reduce the interior side yard setback from the required 3.0 metres to 2.1 metres in order to accommodate the pool equipment.
