OPSS 206 shall apply except as amended below:

The bid price shall include excavation and grading required to establish ditch line and side slopes to match adjacent ground and adjustments as needed to ensure positive drainage to the main cross culverts and entrance culverts.

Payment will be by the linear metres as measured in the field and shall include all costs for labour, material and equipment to construct the ditches and move any excavated material on site.

The linear metre price tendered shall be full compensation for any stockpiling, and/or double handling and transportation of excavated material to be used on site as backfill, in embankments for slope flattening (OPSD 202.010) etc. and shall include all costs for labour, material and equipment for placing, grading and compacting any excavated soil used on site.
